Each year, every Member is assessed an annual fee (the "Annual Dues") to fund the operation of the Club for the current year. If you do not provide notice by March 20th, you will be responsible for payment of that year's Annual Dues. The Board approves the amount of the annual dues each year based on the budget and our expected Membership numbers.
